Technical instructions

1. Scope of work:- Procurement of Blank for Wheel Dia- 500, Blank for Wheel Dia- 630 & Blank for Wheel Dia- 800 .
2. Wheels to be manufactured and supplied as per drg. and its technical instructions indicated in the Drawings.
3. The bidders should have following manufacturing facilities of their own.
 - a. Own forge shop with calibrated re-heating furnaces.
 - b. Own heat treatment shop with furnace Homogeneity/Uniformity calibration BS2M- 54,1991 or Api-6A standard.
 - c. Facilities for secondary refining, vacuum degassing and bottom Pouring of ingots.
 - d. In house duly calibrated testing facilities for ultrasonic, hardness, mechanical chemical, MPT, LPT DPT and Gas analyzer.
4. Raw material (Ingots) should confirm to following technical parameters and mill test certificates should indicate the same.
 - a. Gas Level (H₂ – 2 PPM max O₂ 50PPM Max N₂ 100PPM Max.
 - b. Chemistry as per 65C6 IS: 2004-91.
 - c. Route of manufacturing of Steel (EAF/LRF/VD).
5. The following documentary evidences duly attested by CE should be furnished along with technical offer.
 - a. List of Forging facilities. Heat treatment shop, list of machinery facilities.
 - b. Facilities for steel melting including secondary refining & vacuum degassing.
 - c. Copies of purchase orders for similar items executed in last 2 years on the Scheduled date of tender opening
6. Ordered Wheels should confirm to following technical parameters.
 - a. Forging should undergo reduction ratio of 4:1(minimum) including upsetting reduction ratio of 2.5:1.
 - b. Wheels Should be supplied in soft annealed condition.
 - c. Materials should be ultrasonically guaranteed as per IS: 8791 Class-B or FFS235 HEC standard.
7. **Bidders have to submit the details of Manufacturing, Machining and Forging facilities along with Technical Commercial Bid Part-1.**
8. Forging blanks to be procured in rough machined condition.
9. Round off sharp edges and corners.

Terms & conditions

1. The rate quoted shall be **F.O.R HMBP** (inclusive of packing & forwarding, Freight charges & transit Insurance).
2. The price quoted by the tenderer should be exclusive of sales Tax/ VAT. The rate and nature of sales tax applicable should be shown separately. Sales Tax will be paid to the seller at the rate at which it is liable to be assessed or has actually been assessed on the date of supply provided the transaction of sale is legally liable to sales Tax and within the delivery period. Any change on the taxes & duty structure beyond the delivery period will not be considered by HEC.
3. The rates quoted must be firm and the offer made must remain valid for acceptance for **three months** from the date of opening of the tender. The rate quoted must be in word and figure as well. In case any discrepancy in rate given in figures and word, the rate given in words will prevail.
4. Quotations erased or over written are likely to be rejected unless all corrections are authenticated with the tenderer's signature with seal.
5. **Payment terms:** 90% within two months of receipt of material in HMBP and 10% against C.R.V and submission of PBG as per clause no. 19.
6. Delivery Schedule – **60 days** from the date of issue of PO.
7. Full particular i.e. specification, literature and or drawing wherever applicable should be submitted along with the quotation. The brand and make name must be indicated.
8. The Corporation does not pledge itself to accept the lowest or any tender and reserve to itself the right of accepting the whole or any part of tender or portion of the quantity offered and you shall supply the same at the rate quoted.
9. Inspection of the manufactured items will be done by QCA/HMBP at supplier's works necessary tools and measuring instruments to be provided by the supplier.
10. Order placed as a result of this tender will be governed by the Corporation's General Terms and Conditions of Contract which can be referred in HEC's website www.hecltd.com
11. Corporation reserves the right to call for and examine at any time the books of accounts and other document and papers of the firm for the purpose of ascertaining whether any excess payment has been made or the firm likely to be received / received undue benefit out of execution of the particular contract.
